TERMS OF SALE

Payment Terms

- Accepted Payment Methods: Cash, Credit Card (Visa / MasterCard / AmEx), company or personal check.
- Customer Installation: 75% deposit with order, balance due upon product pick-up at Oregon Glass Block.
- OGB Installation:
 - Deposit: 75% of shower enclosure amount with order (excludes installation cost)
 - Balance due upon notification of product arrival at Oregon Glass Block
 - Installation charge due upon completed installation

Product Orders

- All Shower Doors orders are considered "Special Order" item and are subject to manufacturer's production schedule.
- Unless otherwise specified, customer is responsible for product installation.
- Customer is responsible for the accuracy of all measurements or dimensions
 - Exception: when OGB on-site installation service is purchased
- Claims for product shortage or damage are not allowed unless made within 24 hours of delivery and/or pick-up.
- All products must be picked up within 5 business days of notification of product arrival at OGB.

Product Returns

- Only normal inventory goods can be returned for credit, special order items are non-returnable.
- Product must be returned within 15 calendar days of purchase date and must be accompanied by sales receipt.
- Refund amount issued to purchaser only, in the amount of the invoiced price of the goods, less restocking fee.
- All product returns will incur a 25% restocking fee unless otherwise specified on receipt by OGB representative.
- Product damaged during installation is the responsibility of the customer and cannot be returned for credit or exchange.

Product Delivery

- Special orders are F.O.B. origination point and freight will be added to your invoice.
- OGB is not responsible for delays caused by strikes, fire, accidents, inclement weather, product manufacturer or distributor, transportation companies, or other causes beyond our control.
- Any order shipped via Freight Carrier will be Prepaid and Add. The choice of freight carrier is the discretion of Shipper unless shipping "freight collect" or "third party billing" per customer's request. Any item delivered by carrier cannot be left without a signature by the customer. If a delivery cannot be made by the shipper on the first attempt, extra charges may be added.

Right to Lien

- Subcontractors, material or equipment suppliers and others are required to give the Notice of Right to Lien to residential property owners to protect their right to later file a lien. The Notice of Right to lien is not a lien. Notice of Right to Lien forms will be provided upon client project approval.

Products and Pricing

- OGB reserves the right at any time to modify, upgrade or discontinue, any items in our product line and/or product pricing without notice.
- Estimates for OGB products and services above are valid for 30 days from estimate date.
